ON THE APPLICATION of the Petitioner, College of Veterinarians of British Columbia, without a hearing and by consent:

### THIS COURT ORDERS that:

- 1. The Respondent, Grant MacKinnon until such time as he becomes a registrant in good standing of the College, is permanently prohibited and enjoined from doing the following within the Province of British Columbia, in his personal capacity or under any business name, including MacKinnon Equine Services, whether or not for or in expectation of a fee, compensation or reward;
  - (a) practicing medicine, dentistry or surgery, including dental surgery, on any animal, without limiting the generality of the foregoing, in particular:

- floating or filing an animal's teeth using power tools or manual tools;
- (ii) balancing or equilibration of an animal's teeth;
- (iii) extracting or removing teeth from an animal;
- (iv) administering sedation to an animal for the purpose of performing any procedure on or providing any treatment for the teeth of an animal; or
- (v) cutting or otherwise removing hooks from the teeth of an animal;
- (b) diagnosing or offering to diagnose an animal for the prevention, alleviation or correction of disease, injury, pain, defect, disorder or other similar condition;
- (c) treating or offering to treat an animal for the prevention, alleviation, or correction of disease, injury, pain, defect, disorder or other similar condition;
- (d) administering a drug, serum, medicine or any substance or remedy for the cure, treatment or prevention of an animal disease injury, pain, defect, disorder or other similar condition;
- (e) prescribing or administering a treatment or performing an operation or manipulation or supplying or applying any apparatus or appliance for the cure, treatment or prevention of any animal disease, injury, pain, defect, disorder or other similar condition;
- (f) alleging or implying in any manner that he is qualified or willing to do any of the items (a) to (e) above, within the Province of British Columbia.

2. Until such time as he becomes a registrant in good standing of the College the Personal Respondent is prohibited and enjoined from taking or using any name, title, addition or description which states, implies or is calculated to lead people to infer that he is a veterinarian or veterinary practitioner or that he is a registrant of the College, and in particular, that he is prohibited and enjoined in his personal capacity or under any business name including MacKinnon Equine Services from using in British Columbia the title C. Eq. D, equine dentist or Certified Equine Dentist.
